- Debt Service funds at \$403,122.
- Small funds at \$ 32,852.
- NFS account at \$ 2,725,579 (market decrease of \$50,000)
- Total Funds \$ 5,801,298.
- Income to-date at \$ 3,187,833.
- Expenses to-date reported at \$2,159,304.
- Most line items are within the 83.33% mark at this time.
